## **1. The next NoPSA Congress in Norway 2023/24**

The University of Bergen suggests that the next NoPSA Congress will take place from the 13<sup>th</sup> to the 18<sup>th</sup> of August 2024. The possible venue of the Congress was discussed. In addition, the registration fees/packages and financial matters were discussed. The possibility of having two registration packages, one included with a dinner and one without, was discussed. *It was decided to discuss with the local organisers about this suggestion.*

*The board agreed on the dates of the next congress. The next steps would be to contact the organisers of the congress to discuss the aforementioned points. Are Vegard Haug and Marianna Riddervold will be in contact with the organisers.*

## **2. NoPSA Travel Fund for Young Scholars.**

Eva H. Önnudóttir introduced the drafted document. It was discussed to add other items to the draft; e.g. flights and all the autonomous areas in the Nordic countries (Greenland, Faroe Islands and the Åland Islands).

The grant amount and the amount of grants to be given out was discussed. It was discussed that there should be five grants given out, the same amount of grants as the amount of Nordic countries. *The board decided that the grant amount should be increased and that the grants given out should be up to five per year.*

The procedure of the grant application was discussed, when the grants would be given out and whom from the board would be responsible for the procedure. *It was decided that the grants would be given to PhD students to travel to other Nordic countries than the ones they are studying in.*

A further discussion on the procedure will take place during the next board meeting. It is foreseen that this be implemented in late 2022/early 2023.

*Eva H. Önnudóttir will revise the draft and send an updated draft to the board.*

## **3. The Status of the Skytte Lecture in the SPS**

There are limited updates since the last board meeting. The board wants to continue the Skytte Lecture in the SPS.
